If starting here, go to the directions in the shaded box. Otherwise, follow the unshaded directions.

Give the child two more blocks, for a total of four, and say: **Now you have four blocks.**

Indicating the pattern in Sample D, say: **You will need them all to make this pattern. Watch me put them together.**

Skip to the text following the shaded box.

Place four blocks in front of the child and say: **Look at these blocks. They have different sides**

Turn the blocks to show the various faces and say: **Look at the different sides of your blocks.**

Make sure the child examines his or her blocks. Open Stimulus Book 1 to Sample D and say: **We can put them together so that the tops of them make this pattern. Watch me put them together.**

Using the child's blocks, construct the pattern next to Stimulus Book 1 so that the child can compare the patterns. Then mix up the child's blocks, give them to the child, and with stopwatch in hand, say: **Now you do it. Let me know when you've finished. Go ahead.** Start timing.

SECOND TRIAL (if needed)

If the child's first response is incorrect or the child does not create the correct pattern after 60 seconds, follow the second-trial procedure.

1. **Show the error:** Point to the incorrect portions of the child's pattern and the model, and say: **That's not quite right because this part should look like this. Watch me.** Or, if it is not possible to point to the error(s), simply say: **That's not quite right. Watch me.**
2. **Demonstrate:** Mix up the child's blocks and demonstrate the correct pattern.
3. **Try again:** Mix up the child's blocks and say: **Try again.** Start timing.
